2009 MUTTON BUSTIN' RULES

Entry Deadline: Saturday, September 19, 2009 10:00a.m.-12:00p.m.

Contest Dates: Friday, October 9, Saturday, October 10, Sunday, October 11, 2009 during the Rodeo performance.

Entry Fee: \$25.00 VISA/MASTERCARD

1. Entries will be accepted on Saturday September 19, 2009 10:00a.m. to 12:00p.m. at the Brazoria County Fairground Rodeo Arena. Entries will be accepted on a first come, first serve basis until all positions are filled.
2. Entry Form will not be accepted without **(1) CONTESTANT WAIVER AND RELEASE FORM, (2) ENTRY FEE OF \$25.00, AND (3) A COPY OF BIRTH CERTIFICATE TO BE LEFT WITH THE APPLICATION.**
3. "Top 45" entry fees are non-refundable!
4. The first 45 entries ("Top 45") will be accepted and the following 6 entries (2 per night) will be classified as alternates.
5. In the event that a "Top 45" entry does not qualify due to weight or is unable to ride, the next eligible alternate will move into the "Top 51".
6. Weight limit is 55 lbs. on day of weigh-in. **Weigh-in is September 19, 2009 at the arena from 10:00 a.m. to 12:00 p.m.**
7. All entries **must** weigh-in on September 19th or will be disqualified from participating.
8. No youth under four (4) years of age or over the age of (8). Proof of age (copy of birth certificate which will remain with application, is required.)
9. You must report to the arena by 5:30 p.m. on Friday night, by 5:30 p.m. on Saturday night, and by 2:00 p.m. on Sunday afternoon. A contestant number will be issued at that time and must be worn during the entire event.
10. Helmets and vests will be provided and are **Mandatory**. You may bring your own bicycle helmet.
11. Long Sleeve shirts and pants are required.
12. Only one parent will be allowed in the arena.
13. No ropes or spurs.
